

Minutes from September 6, 2022 Meeting

- Commissioner Dodley requested attendees to Pledge of Allegiance.
- Chair Commissioner Chamberlain called for Roll Call introduction of Commissioners.
- All Commissioners, Chair Commissioner Chamberlain, Vice Chair Commissioner Moynihan, Secretary Commissioner Tyree, Treasurer Commissioner Holmes, Zoning Chair Commissioner Marshall, Commissioner Dodley and Commissioner Johnson, were present.
- Approval of Former Meeting Minutes
 - Chair Commissioner Chamberlain asked Commissioners to review July 5, 2022 Minutes which resulted in no modifications. Commissioner Holmes made a motion, which was seconded, to approve July 5, 2022 Minutes. Roll Call Voting resulted in unanimous approval.
 - Chair Commissioner Chamberlain asked Commissioners to review July 12, 2022 Special Meeting Minutes which resulted in no modifications. Commissioner Chamberlain made a motion, which was seconded, to approve July 12, 2022 Meeting Minutes. Roll Call Voting resulted in unanimous approval.
